Call to Order: Meeting called to order by Mayor Adams at 7:00 p.m.

Eric Volkman from Prospect Bank (Sewer Loan) and local bank facility: Mr. Volkman presented information about the loan for the sewer project. He also stated that Prospect Bank is interested in having limited bank in Westfield. He discussed some of the remodel requirements.

**Approve March Regular and March Special Meeting Minutes**: Dollahan made the motion to accept the regular and special meeting minutes. Wheeler seconded the motion. Motion carried. Approved

**Approve Payment of Bills:** Wheeler asked why the library doesn't pay their bills. She asked for it to be on the next agenda. Motion to accept payment of bills was made by Dollahan, seconded by Wheeler. Hacker, aye, Dollahan, aye, Livvix, aye, Stone, aye Wheeler, aye, Robison, aye. Motion carried. Approved.
